INTRODUCTION BY PROJECT LEADER

ExCEL3 (Excellence in Capacity-building on Entrepreneurship and Leadership for the Third-sector) Project under the Faculty of Social Sciences of The University of Hong Kong, supported by The Hong Kong Jockey Club was officially launched on May 7, 2012.

This cross-sectoral inter-disciplinary project aims to build the capacity of non-government organisations and empower civil society in Hong Kong, as well as build research and teaching capacity in the study of civil society within the University. Through training, sharing, and research, the Project seeks to nurture innovation and entrepreneurship, to strengthen the leadership, management, governance and organisational capacity of the third sector; and to build a platform that brings together philanthropists, foundations, and institutional investors with non-government organisations, as well as the academic community.

The Project has established collaborative networks in Hong Kong and overseas with a large number of organisations including environmental groups, women's organisations, artists groups, faith-based organisations, human services organisations, advocacy groups, patients' groups, self-help organisations, philanthropic trusts, and social entrepreneurs. The Project has already extended the reach of the Faculty into the third sector. Although our scope of activities is initially Hong Kong focused, we seek to engage the third sector in Great China and overseas, and to recruit the best talent available to the Project.

Advocacy

Advocacy is the process by which one speaks in support of a specific interest although its usage has evolved to mean the political process by which one aims to change or influence existing or proposed policies or practices on behalf of or with a specific individual or group. It involves focused efforts to influence public policy and resource allocation decisions, usually on behalf of or with minority or disadvantaged groups in society, in a way that represents their best interests. Lobbying is a type of advocacy that attempts to influence decisions made by the government. The more noble aims of advocacy are to: ensure underprivileged populations enjoy equal access to information, support and opportunities; promote social inclusion and reduce discrimination; empower disadvantaged groups; protect human rights; and ensure a better quality of life for all.

Citizenship

The basic definition of citizenship is tied to the status of a person's relationship with the state or association of states where said person has the rights and duties of a citizen. The idea and practice of "active citizenship" goes beyond the more narrow definition that equates citizenship with the presence of political participation, which is only one component of it, to include the concepts of social capital. The components of active citizenship include psychological, as in one's sense of belonging; civil; political; social; and caring, which defines one's sense of both rights and responsibilities. This model of active citizenship takes into account both the individualistic and collective nature of citizenship.

Civic Engagement

Civic engagement is those individual and collective actions that address issues of public concern and at its most basic is about the rights of citizens to participate in deciding on the public good and how those public resources are allocated. The fundamental principle of civic engagement is tied to the notion of democratic governance in that the right to rule resides in each of the citizens. Civic engagement ranges from those informal and individual actions, such as volunteering and community service, to engagement at the organisational level through to the more formalized and collective action of citizens, such as participative democracy.

Evidence-based Practice

The basic principles of evidence-based practice are that all practice decisions (e.g., formulating objectives and strategies) made should be based on not only clinical experience, client values and preferences but also research evidence. Evidence-based practice is advocated in a background that there are many practices being "innovated" every day and many of them, however, seem to be re-inventing the wheel. It is important to collect scientific evidence about "what really works". The credibility of research evidence is reviewed and interpreted before being taken into account in practice decisions. Outcomes of practices are evaluated with proper scientific methods and reported for collective wisdom of best practices.



Leadership and Governance

Board governance aims to ensure the strategic guidance of the NGO, the effective monitoring of the organisation's management, and the board's accountability to its key stakeholders, from service users and donors to the community and public in general. Strategic leaders are not passive recipients of changes in the environment and organisations, but rather can be dominant forces in affecting change. Strategic leadership involves interpreting the environment, crafting strategies, and building an organisation that thrives in dynamic environments. Building an organisation involves all means (e.g., structures, institutions, culture) to exploit and maintain an organisation's competitive advantages and to assure balanced organisational controls in the service of the organisation's vision and mission. Moreover, to leverage resources in, strategic leaders need to go beyond organisational and service boundaries and seek partnerships with other civil society actors of which collective efforts and voices will bring synergy, build community and social capital and benefit public governance.

Philanthropy

The etymology of "philanthropy" is the combination of two ancient Greek words: "philos" meaning "loving" in the sense of benefitting, caring for or nourishing; and "anthropos", meaning "human being" in the sense of "humanity". Philanthropy, therefore, can be translated as meaning "love of humanity". In the modern world, philanthropy is generally understood as voluntary action or private giving of time or valuables for the public good, or more specifically, for improving the quality of life of all human beings. There are different factors that can lead to philanthropic giving, for example, religious belief, personal values, family or cultural tradition, as well as different vehicles for doing philanthropy. Philanthropy plays an important role in the development of civil society and how philanthropy happens will continue to evolve as we seek to maximize the way our contributions impact society for the better.

Social Entrepreneurship and Innovation

Social innovation looks to new ways, from strategies and concepts to processes and organisations, of attempting to address the needs of society. Social entrepreneurship has emerged in the last few decades as one response to addressing social issues, whereby individuals, groups, organisations or networks seek sustainable, large-scale social impact through innovative ideas that challenge the prevailing wisdom. Social entrepreneurship takes a blended values approach, that of delivering social change using concepts and principles from the business public or third sectors. Any profit earned through social entrepreneurship is reinvested back into society. Social entrepreneurship takes into account the "double" or sometimes even "triple" bottom line, not just individual gain but also social and ecological good.









Colleagues from HKU in collaboration with nonprofit organisations have developed fifteen collaborative projects, categorised in accordance with the ExCEL3 Project themes, into different focuses.

Building Capacity for Grassroots Women Organisations

Objectives

- To develop a network to promote women's rights through training workshops/ community forums
- To empower this network to enhance their competence in running their organisations, media relations, financial management and fund raising

ExCEL3 Institutes

ExCEL3 provides a large array of knowledge transfer activities ranging from professional education, executive training, and service workshops, targeting on audiences from different backgrounds with different needs—from civil society leaders to NGO executives to the general public. Other than disseminating knowledge, these activities provide a platform in which knowledge exchange and engagement take place, which not only help build capacity of the third sector but also enhance its transparency. Renowned scholars and practitioners are invited to share their insights on major topics and issues in NGO management and new developments of the third sector, including strategic management, performance measurement, social innovation, social impact assessment, and social auditing.

evvice Institute

Service Institute provides workshops and seminars that help front-line professionals enhance their practical knowledge and skills.



Executive Institute helps senior executive to develop managerial skills and knowledge of best practices that enable them to exercise effective leadership.



Community Institute promotes knowledge exchange through symposia and seminars on topics that are of interest to the general public.

Case Bank

Teaching cases are an effective pedagogical tool that enriches students' learning experience as well as increases learning effectiveness. Through providing a descriptive narrative of problem scenarios, teaching cases present a learning context in which students develop skills in defining problems, suggesting possible solutions, and making reflective management decisions. Through a partnership of the Hubert Project—an international open source case repository for public affairs education conceived and incubated in the Public & Nonprofit Leadership Center at the University of Minnesota, ExCEL3 is taking the lead to build a world-class case bank that not only documents successful experiences in NGO management and public governance, but also builds reusable materials for education programmes and professional training. The leadership that we provide in the Hubert Project will position The University of Hong Kong as a knowledge hub for NGO management education in Greater China and Asia-Pacific.

Research

ExCEL3 is conducting a number of key research projects that examine issues of major importance to the development of Hong Kong's Third Sector, including:

Citizenship and Giving

- To examine the civic, political, and social rights and duties as envisioned and experienced by the citizens
- To explore the bases of inclusion and exclusion
- To ascertain the relationship between the citizens and the sovereign state as well as the HKSAR government
- To understand the structure of social capital in Hong Kong

NGO Leadership and Governance

- To understand and consolidate service provision and management experiences for better governance of NGOs in Hong Kong
- To identify governance mechanisms of nonprofit organisations to inform board practices and future research as well as theory development of NGO governance
- To build models and cases of nonprofit management for trainings of executives and board directors in Hong Kong

Effective Philanthropy in Private Foundations

- To enhance understanding about private foundations in Hong Kong
- To understand private foundations' perception of "effective philanthropy"
- To identify good practice among the philanthropic family foundations

Academic Programme

We will collaborate with Indiana University, the provider of the top-ranked nonprofit management degree programme in the world, to launch a dual degree taught postgraduate programme in nonprofit management in September 2014. The Master in Nonprofit Management degree is intended for emerging leaders from the third sector in Hong Kong and regionally and is designed to provide them with the skills and knowledge of sound nonprofit management and governance principles. The research and knowledge that is being generated through the ExCEL3 Project will serve as part of the foundational material for this degree programme.
