	<p><b>Dr Edward Brooks</b></p> <p>Dr Edward Brooks is the Executive Director of the Oxford Character Project and head of its Global Leadership Initiative. His work joins research in the areas of leadership and character development to practical programmes at the University of Oxford and beyond that focus on the virtues needed for leaders to serve the public good. He is currently editing a book on <i>The Arts of Leading: Perspectives on Leadership from the Humanities and Liberal Arts</i>, and finishing another book on the virtue of hope: <i>What May I Hope For? Modernity and the Augustinian Virtue of Hope</i>. He holds a BA in Modern History and DPhil in Theology, both from the University of Oxford.</p>
	<p><b>Prof Samson Tse</b></p> <p>Professor Samson Tse is Associate Dean (Undergraduate Education) of HKU's Faculty of Social Sciences and also Professor of Mental Health in the University's Department of Social Work and Social Administration. ### **Dr Mike Brownutt**


Mike Brownutt obtained his first Master's degree (MSci in physics) and his PhD (in experimental quantum mechanics) from Imperial College London. Following this he moved to Innsbruck, Austria, for eight years, firstly as a post-doctoral researcher and later as an Assistant Professor. He wrote his habilitation based on his research there, which centred on developing scalable architectures for quantum computers. Throughout this work he held an abiding interest in the relationship between science and religion. He completed his second Master's degree (MA in theology from the University of Chester) considering how faith is understood by various parties in discourse on the relationship between Christianity and science. Since 2015 he has worked at the University of Hong Kong, where he is Associate Director of the *Faith and Science Collaborative Research Forum*.

He subsequently received a JD from NYU Law and began his career practicing commercial litigation in New York, first with Shearman &amp; Sterling LLP and later with Simpson, Thacher and Bartlett LLP. In 2006, he returned to Asia and worked with his family in managing personal investments both in the private and public markets. In conjunction with this role he has advised and sat on numerous boards of both startups and more mature companies in such industries as advanced manufacturing, real estate, internet app development, funeral services and others. He now is based in Hong Kong.</p>
	<p><b>Prof Daniel Chua</b></p> <p>Daniel KL CHUA earned his PhD in musicology from Cambridge University and is currently Professor and Chair of music at the University of Hong Kong. Before joining HKU, he was the Director of Studies at St John’s College, Cambridge, and later Professor of Music Theory and Analysis at King’s College London. He was a Visiting Senior Research fellow at Yale (2014-15), a Henry Fellow at Harvard (1992-3), and a Research Fellow at Cambridge (1993-7). He is the recipient of the 2004 Royal Musical Association’s Dent Medal. He was editor of <i>Music &amp; Letters</i>, and is on the editorial board of major musicological journals. He was a Director-at-Large of the International Musicological Society and is currently the Society’s President (2017-2022). He has written widely on music, from Monteverdi to Stravinsky, but is particularly known for his work on (i) Beethoven, (ii) the intersection between music, philosophy and theology, and (iii) the history of ‘absolute music’. His publications include <i>The ‘Galitzin’ Quartets of Beethoven</i> (Princeton, 1994),</p>

	<p><i>Absolute Music and the Construction of Meaning</i> (Cambridge, 1999), <i>Beethoven and Freedom</i>, (Oxford, 2017), 'Rioting With Stravinsky: A Particular Analysis of the Rite of Spring' (2007), 'Beethoven's Other Humanism' (2009), and 'Listening to the Self: <i>The Shawshank Redemption</i> and the Technology of Music' (2011). He is currently collaborating on various theologically inflected projects based at Duke and Yale Divinity Schools, and is working on a post-human manifesto modestly entitled an <i>Intergalactic Music Theory of Everything</i> (IMTE).</p>
	<p><b>Elsa Lam</b></p> <p>Elsa began her career as a journalist in Hong Kong and later devoted herself for more than a decade to poverty alleviation in China and Vietnam with World Vision, where she was Head of Operations Department and Sponsorship Director at different times. **Karen Liu Chau**

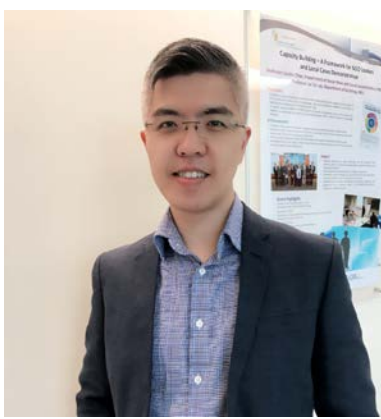
